


Q1 - Select the committee you served on this academic year, for which you are completing this survey. (If you served on more than one committee you will get this survey more than once.)




Q2 - This academic year I attended Fiscal Planning Committee meetings:


We go through a lot of information fast. We do get time for questions. Very informative but sometimes the numbers a little over our heads.






