A. Credit for Prior Learning (CPL)

- S. Relle displayed the recently approved <u>Petition for Credit for Prior Learning</u>
- Method of CPL used will show on the student transcript. Concerns: Students might have one goal when they start, but a different goal later on, how will this affect those students that want to transfer? CPL might not work for some schools, how do we address that? How much CPL can be applied?
- Campus workgroup meeting to be scheduled soon.
 - Faculty is encouraged to join the meeting and be part of the conversation. CPL helps address an equity issue, and it gives students opportunities to apply prior skills and knowledge gained outside of the classroom and earn CPL.

C. Graduation Requirement – Ethics Studies

Recommendation from the district: hold on implementation until we receive clear guidelines from the State Chancellor's

D. Guided Pathways (Traci Allen)

- Currently in three different areas:
 - PDF maps are in Canvas, which is not ideal for access
 - o DegreeWorks; based on PDF template and map is emailed after counseling
 - o Program Mapper was presented, this is new software soon to launch, and builds from the catalog
- Moving forward, is there value in maintaining and updating all three places?
 - Who will update? T. Allen will update until December 2021
 - When will updates happen? Concern: Consider workload, if one area is not updated, students could receive incorrect information
- · Reminder: when updating courses, update affected programs too, this affects information given to students
- All three colleges are working to have the same information display, this way students get the same experience when viewing the Program Mapper
- Current status: T. Allen to notify Deans and Dept. Chairs regarding missing programs
