1. Call to Order, Public Comments, Approval of 11/14/17 Minutes	<p>Public comments:</p> <ul style="list-style-type: none"> •Nenagh announced that the Guided Pathways Forum is Jan. 19th from 8 am – 12 pm with a workgroup training session in the afternoon. Academic Senate is voting on the Guided Pathways assessment plan. Nenagh mentioned that according to Chancellor Oakley, Guided pathways are here to stay. Although, Santa Rosa College officially voted against them. There is more latitude with what to do with Guided Pathways, so Nenagh encouraged that faculty/staff attend the Guided Pathways Forum to have a voice. A question to think about is, "How do SLOs fit into Guided Pathways?" The goal for spring semester is to come up with the plan. If SLOs are

	<p>being used as data, they would support the fourth pillar of Guided Pathways, "Ensure Learning."</p> <ul style="list-style-type: none"> •Dean of Mathematics & Physical Science is working on a permanent replacement for Scarlet (whether it is for SLO committee or GE workgroup). •Question: Julie would like to know for faculty that teach at VC & MC, who is the appropriate person to refer them to at VC for SLO assistance. Does VC have a SLO Coordinator? •Did not have quorum to approve November minutes.

SLO Coordinator Report</p>	<p>Highlights from Mahta's SLO Coordinator Report:</p> <ul style="list-style-type: none"> •GELO meeting for Area C: Arts and Humanities was successful. 13 individuals attended the meeting to discuss current GELOs and plans for assessing them. Currently, Humanities and Arts are not assessing GELOs (although they are assessing CLOs). Plans were made to assess GELOs in 2018 using a common data collection sheet which Mahta will send out. •Scarlet mentioned the importance of documenting GELOs and asked where they are presently documented. Currently, the GELOs are entered on a data collection sheet which is sent to Mahta. Carol stated it is appropriate for GELOs to be documented in TracDat similar to CLOs. •It was recommended that courses approved for GE should have a GELO documented in TracDat and that the GELO be stated in CurricuNet or the next system. •Nenagh stated that GELO results will go to GE committee. Area D is next to be reviewed in the 5 semester or 5 year cycle. <p>ACTION:</p> <ul style="list-style-type: none"> •Carol will talk to IE staff regarding the possibility of creating a GELO tab in TracDat similar to the CLO tab to document progress on the GE learning outcomes. •Carol will check if Mahta has access to TracDat in order to update CLOs and enter GELOs when created. •SLO Committee agenda item for next meeting: Create a new GELO cycle by the end of the semester
