## **Special Admission Nonresident Tuition Exemption Request**

For Eligible Special Part-Time Students

Special admission students who are determined to be nonresidents may be exempt from paying nonresident tuition per California Education Code Section 76141.

- The term "special admission student" refers to concurrently enrolled K-12 students who have been recommended by the principal of the pupil's school and have parental permission to attend a community college during any session or term and who enroll in 11 or fewer units per semester, in accordance with California Education Code <a href="Section 76001">Section 76001</a>. (Except parental permission may not be required for special admission students who are 18 years of age or older.)
- The exemption does not apply special admission students enrolled in 11.5 or more units.
- This exemption does not apply to categories of students who would be precluded from qualifying for AB 540 nonresident tuition exemption; i.e., a) students who reside outside of California and enroll via Distance Education and b) students on most nonimmigrant visas (e.g., F-1 International Student visas, etc.). T and U nonimmigrant visas are eligible for this exemption.
