## I. Organizational Items

a. Call to Order

#### **III. New Business**

#### a. Discussion Item: Change in Registration Timeline – Dave Anter

MC Registrar Dave Anter and a representative from the MC Counseling Office discussed the changes in the registration timeline for new and continuing students.

#### b. Discussion Item: ASMC Elections - Jennifer Pezzuto

ASMC Director of Constitution & Rules Jennifer Pezzuto encouraged ICC members to consider running for an ASMC Board of Directors position for 2018-2019, and shared the elections timeline.

#### c. Discussion Item: Purchase Window Closing - ICC Chair Donna Rahgoshay

ICC Chair Rahgoshay reminded clubs that the deadline to submit a requisition to create a Purchase Order is Friday, April 13, and that the deadline to submit a requisition for petty cash is Friday, May 4, 2018. The deadlines are in place to allow for reconciliation of all 2017-2018 FY expenses.

- d. Discussion Item: Standing Rules Appeals Process ICC Chair Donna Rahgoshay ICC Chair Donna Rahgoshay share the change in the ASMC Standing Rules that now allows for clubs to appeal when they have been suspended.
- e. Action Item: History Club Appeal ICC Chair Donna Rahgoshay

ICC Chair Donna Rahgoshay led the ICC in a discussion on whether or not to allow the History Club's appeal for reinstatement to advance to the ASMC Board of Directors for final consideration. After discussion, the ICC voted:

- i. Alex Littaua (Enthusiastic Programmers) moved that the ICC allow the History Club to be considered by ASMC for reinstatement as a formally recognized club.
- ii. Juliet Delgado (Film Club) seconded the motion.
- iii. ICC voted, with the majority voting in favor of the motion, 8 abstaining from the vote, and 1 dissenting (Javier/SPACE Club).
