Programming Committee, Regular Meeting Minutes

Thursday, October 19, 2017 from 4:00 PM – 5:00 PM

Associated Students Conference Room, Moorpark College Campus Center

I. ORGANIZATIONAL ITEMS

- A. **Call to Order.** Director Houston Holohan called the meeting to order at 4:04 p.m.
- B. **Roll Call:** Director Houston Holohan will call the roll of Committee Members:
 - i. **Director of Budget and Finance:** Houston Holohan (present)
 - ii. **Student Organizations Director:** Donna Rahgoshay (present)
 - iii. **Campus Events Director:** Matthew Campbell (present)
- C. **Approval of Minutes.** Minutes from the October 5, 2017 meeting were reviewed and approved unanimously as presented.
- D. **Public Comment.** No public members provided comment.

II. NEW BUSINESS

- A. **Discussion Item: Feminism Today's request.** Student President of the Feminism Today club discussed the group's request for \$1,950 to support its speaker series and future meetings. After hearing from the club representative, the ASMC Programming Committee discussed the proposal.
- B. **Action Item: Decision whether or not to honor the funding request from Feminism Today.** The Programming Committee took action on the funding request.
 - i. *Director Rahgoshay moved to award \$1,950 from the Programming Fund to Feminism Today.*
 - ii. *Director Campbell seconded the motion.*
 - iii. *Motion unanimously approved.*
- C. **Discussion Item: Raider Cheer Squad funding request** The Programming Committee reviewed the funding application from the Raider Cheer Squad, which requested \$3,600 to purchase equipment as well as fund the Squad's end-of-the-year celebration banquet.
- D. **Action Item: Decision whether or not to honor the Raider Cheer Squad's funding request.** Programming Committee members took action on the funding request.
 - i. *Director Campbell moved to award the Raider Cheer Squad with \$1,000 from the Inter-Club Council (ICC) fund.*
 - ii. *Director Rahgoshay seconded the motion, and amended it to provide \$1,400 to the Raider Cheer Squad from the ICC fund.*
 - iii. *Director Holohan seconded Director Rahgoshay's motion, and amended the amendment to give the Raider Cheer Squad \$1,450 from the ICC fund.*
 - iv. *Director Rahgoshay seconded Director Holohan's amendment of the amendment.*
 - v. *A vote was taken, with Directors Rahgoshay and Holohan voting in favor of providing the Raider Cheer Squad with \$1,450 from the ICC fund. Director Campbell was the sole dissenting vote, which resulted in the motion passing.*

III. **REPORTS.** There were no reports from the Programming Committee members.

IV. **TASKS.** No tasks were assigned to the Committee members.

V. **ADJOURNMENT.** Director Holohan adjourned the meeting at 4:32 p.m.
