Track Data	Sociology approach: class, race and gender, something that is already in the course. They can choose to use a written test, or an additional test, or quiz. Sample of the assignment (or a few assignments if people are using different assignments) but remove the students' names. What is a proper way to create evidence, and maintain confidentiality? Also concerned about connecting the instructor to the work.
	Question of student "ownership" of their work came up.
	Figure out how to articulate how we do our random sampling of student work.
	SLOs are not about faculty not doing their job; it is about student learning.
