These documents lay out the district hiring processes for the chancellor, vice-chancellors, college presidents, academic managers, and full-time faculty. Early drafts were provisionally discussed by our AS Council last year and over the summer the Board of Trustees approved the updated Board Policies. They now include statements concerning interim hirings, as recommended by all three Academic Senates.

The Administrative Procedure for part time faculty hiring is being updated with some important additions that would (1) allow immediate employment of district faculty already hired in the discipline at another college, as well as (2) formalize a more expedited emergency process to follow if the hire must occur within 5 days.
