### II) Planning Session

i)

- a) Division/Department Reorganization
  - Reorganization has repercussions on membership of AS Council
  - (1) Senate membership positions are our responsibility and decided by the academic senate through the by-laws(a) Note that by-laws can be changed in the senate council
  - (2) EdCAP, Fiscal, Curriculum, & SLO committees are also affected since each has one representative per department
    - (a) These designations are in the Making Decisions Document and require sign off by Administration, Associated Students, the Classified Senate, and the Academic Senate
  - ii) Idea is to freeze last year's senate membership for one year to allow time for discussion
    - (1) Will bring this resolution to the full membership on Friday at AS General Meeting
    - (2) Discussion points
      - (a) Senate versus assembly system of representation
      - (b) More voices is better is a common theme
      - (c) Some programs now report directly to VP's, so must be careful when considering "programs"
  - iii) Show of support to bring resolution to the Friday General Meeting
    - Unanimous show of support for bringing the resolution to freeze the senate membership to the General Senate Meeting on Friday's Mandatory FLEX Day

#### b) Strategic planning for 2017-18

- i) In the past, it felt like we were responding to events rather than choosing our own path
  - (1) Things that must be performed
    - (a) Constant hoard of AP/BP's
    - (b) Must approve some but not all plans
    - (c) Faculty prioritization
- ii) What do we want to actually focus on?-round robin discussion
  - (1) Support of Part-Time faculty
    - (a) Support paid office hours
    - (b) Office space
    - (c) Acknowledge this is largely AFT
  - (2) Encourage faculty to attend senate—increase awareness and participation
    - (a) Possibly a larger room
    - (b) NFO requirement to attend at least one meeting
    - (c) Introduce 10+1 and the processes of senate
  - (3) Send more senate members to plenaries and institutes (\$\$)
  - (4) More money set aside for ASC conference/training attendance
  - (5) Thoughtful discussion of how to spend senate funds
    - (a) End of year brunch wears too many hats, needs to be focused
      - (b) Bricks, scholarships, etc.
  - (6) Encourage faculty participation/ASC approval of grants and categorical funds
  - (7) Faculty-driven involvement of guided pathways exploration
  - (8) Allocation model discussion in light of Ventura College's change of size
  - (9) Faculty support of increased enrichment experiences for students on and off campus(a) Cross-disciplinary collaboration
  - (10) How to assess our current administration model in relation to the integration of academics and student services(a) Integrated model, how do we preserve it?
