- b) The Partnership Resource Team: Co-presented by Nenagh Brown and Julius Sokenu, VP of Academic Affairs
 - i) There were a number of colleges on sanction, etc. from ACCJC 4-5 years ago during their accreditation process
 - ii) This spawned the Institutional Effectiveness Partnership Initiative (IEPI) to support the colleges
 - iii) Partnership Resource Team (PRT) is one aspect of the IEPI
 - (1) Collegial visit of peers to help support colleges on specific areas of their choosing
 - (2) Moorpark College—chosen areas of focus
 - (a) Integrated planning
 - (i) How to effectively plan, budget, and implement given both general and categorical funds?
 - (ii) How to integrate program plans more fully into our over-arching college plans?
 - (b) Development of institutional advancement plan
 - (i) How to effectively establish a grants office to take advantage of the increasing categorical and grant opportunities?
 - (ii) How to make an in-house grants office sustainable?
