 - (b) Self-assessment due December 23rd: includes 14 elements
 - (i) Voted to approve senate signature with proviso of assessment with no abstentions
 - (ii) Proviso reads: "Signature of Academic Senate confirms that the Self-Assessment was produced by a cross-functional team; before commitment to adopt a guided pathways framework can be confirmed, the Moorpark College participatory governance processes need to be completed."

 - Resolution in Developing and Implementing Guided Pathways Frameworks
 - (1) Take this home, read them, and think about where you think we ought to fall as there are both for & against resolves right now
