I) Public Comments

- a) Thank you to Renee for organizing the "bricks" ceremony
 - i) Foundation has recommitted to donate \$500 for the "bricks" every year
 - ii) and also help support the senate sponsored academic year-end celebration up to \$1000
 - iii) The foundation will also help support the classified bricks and the classified luncheon

II) Approval of Minutes

III) Old Business

b)

- a) Academic Senate Council membership
 - Academic Senate Budget for 2017-18—Presented by Renee Butler, AS Treasurer
 - i) We reviewed the budget last meeting at the end of last semester and this is now the second reading for approval
 - ii) Voted to approve the 2017-18 budget with Vance Manakas abstaining

IV) Consent Calendar

- a) BP/AP 3420: Equal Employment Opportunity Plan
 - i) There was a district-level discussion to add the option for employees to designate themselves as a Veteran or part of the LGBTQIA+ community
 - ii) Voted to approve the consent calendar with no abstentions

V) New Business

- a) Spring Semester Update—Presented by VP AA Julius Sokenu
 - i) New Dean of Institutional Effectiveness (8th dean)
 - (1) PRT team came in November and gave us feedback on requested areas of focus
 - (2) Recommended a research dean with specifics of research and institutional effectiveness
 - (3) Cobbled categorical resources together to fund a Dean of Institutional Effectiveness
 - (4) Will perform a national search for a Dean of Institutional Effectiveness for next year
 - (a) This new position will challenge our integration of academics and student services
 - (b) Looking for ways to fund an administrative assistant for the new dean
 - (c) New dean position will initially be largely funded from PRT money (total PRT funds: \$200k)
 - (5) An additional dean also means a reorganization
 - (6) Carol Higashida and Lisa Putnam's divisions have reshuffled slightly
 - (a) Athletics will be under Dean Lisa Putnam instead of under Carol Higashida
 - (b) The departments themselves remain intact and no other academic department shuffles
 - (c) Services have been altered though
 - (i) Including the Health Center being under Dean Lisa Putnam
 - (ii) As well as Guided Pathways
 - ii) PRT team will come back in February to discuss the menu of options and recommendations
 - (1) And visit again 6-9 months after that meeting to see progress
 - iii) Question about longer term funding, aka "sustainability" of these new positions
 - (1) The basic idea is that new grants must have a research component that includes funding for Institutional Effectiveness
 - (2) Will also look for general funds
 - iv) Question about some of the items that used to be under VP's now being under a dean
 - v) Full-time Faculty Hiring
 - (1) All 8 positions have gone out—4 as funded and 4 contingent
 - (2) Waiting on contract decisions since it will impact the budget (STRS/PERS impact)
 - (3) Looking at newly released budget from the governor and see how to move forward
 - (4) District is over the Faculty Obligation Number (FON) by 33 positions—though Moorpark is below FON proportionately
 - (5) Retirements and hiring accounting—will not push down the prioritization list based solely on retirements
 - (6) Will likely hire more than 4 but very unlikely to hire all 8
 - (7) Note that it is helpful to know about retirements early for future hiring
- b) Updates to Standing Committee Membership for Spring 2018
 - i) Voted to ratify new committee membership with no abstentions
- c) Academic Senate Guided Pathways resolution
 - i) Signed the GP Self-Assessment in December with a proviso, noting that more time is required to complete participatory governance process
 - ii) Will need to get back to the Chancellor's Office with an official statement from the Academic Senate on GP
 - iii) Santa Rosa College signed against Guided Pathways and will not be able to participate in this program
 - iv) Seems like we are boxed into a corner since hiring a dean largely on GP funds
 - v) Draft resolution with 4 resolution options to start the conversation
 - (1) So many rivers, student success, equity, Strong Workforce, and now Guided Pathways that it is confusing(2) Will the money be dependent on making the goals?
 - (a) Perhaps/probably in the future?, but definitely not for the first year
 - (b) The "performance based" funding perhaps will be linked to implementation rather than actual performance
 - vi) Detailed discussion on the resolved statements including some wordsmithing
 - (1) Not everyone is in agreement with Guided Pathways
 - vii) Note that performance based funding is coming but there is still a question whether it is in the vision statement from the state chancellor's office or not
 - viii) The Guided Pathways Plan and its budget will come through Senate; it has to go to Chancellor's Office by March 30th signed by the college president and AS president
 - ix) Voted for Senate Officers to rephrase the resolved statements of the resolution in accordance with the discussion of Council and bring back for vote the next meeting
- d) Academic Senate Year-End Event
 - i) What day and time? Propose Thursday May 17th, the Thursday of finals week
 - ii) Early worked well with classified for the 8-10am time frame

- iii) Will have less participation this year as we will not be paying for all classified
- iv) Will decide the date and time at the next senate meeting
- e) Academic Senate Scholarships
 - i) Suggestion to keep the status quo of a maximum of three \$500 scholarships
 - ii) Suggestion to use \$1500 every time
 - (1) Either 3 at \$500
 - (2) Or if only 2 then \$750 a piece or \$1000/\$500
 - iii) Suggestion for two at \$1000 a piece—would go further for the students that receive the funds
 - iv) Final decision to be made for the next academic year's budget
 - v) Senate Scholarship Workgroup to
 - (1) Discuss issues such as how to interface with the college's new scholarship electronic system and the number and amount of funds for each scholarship
 - (2) Perform the final selection of scholarship recipients
 - (3) Jolie Herzig, Tiffany Pawluk, Renee Butler, Mike Hoffman, and Erik Reese have volunteered to participate on this workgroup
