- a) Academic Senate Council membership
 - i) Work group has met twice and are starting to realize the scope of the project
 - ii) Looking at the division and department structure of senate membership in light of the ever-shifting landscape

- iii) Many schools have one member per division and then the number of representatives is based on the number of faculty (1 member for every 9 faculty, for example)
 - (1) Easy for colleges that do not have a lot of changes
- iv) By end of semester need to have new council membership in place as we know a restructure of some sort is coming as Norman Marten steps down from dean to return to the classroom (see President's report for more details)
 - (1) Recommendation to be brought to senate council no later than the March 20th meeting for completion before the end of the semester
- b) Academic Senate Guided Pathways resolution
 - i) Academic Senate potentially has 2 votes corresponding to 2 signature opportunities this semester
 - (1) Today's vote is GP as a concept
 - (2) Commits us to developing a plan for implementing a Guided Pathways framework and releases the funds from the Chancellor's office to the college
 - (a) If we do not sign then the college does not receive the funds
 - (3) Next signature is for the plan that encompasses the first 18 months
 - (a) This one will involve a detailed plan for MC and a budget
 - (4) New state California Promise program is linked to 6 things, including participating in Guided Pathways, so participation in GP is a requirement for Promise program participation
 - ii) Vigorous and detailed discussion last time and was sent to the senate officers for revision
 - (1) Updated version that reflects this discussion was brought to this meeting ideally for vote
 - iii) Questions on what we are signing up for during this vote
 - (1) This signature is MC's participation in GP: only to plan the plan at this stage
 - (2) Budget discussion will be part of the more detailed plan that Moorpark College drafts
 - iv) Comment: Would like to see support for the students with the money going more directly to the students
 - y) Question on the district's role for MC's implementation of Guided Pathways
 - (1) Individual college GP plans but could possibly affect software purchases within the district vi) Comment: GP is tied to other funding as well
 - (1) Promise program requires participation in GP
 - (2) If we choose not to adopt GP, then students will likely go elsewhere, to colleges that provide that support
 - vii) Comment: Any support for our students is good for the students
 - viii) Question: Will GP funds be linked with completion data?
 - (1) For Strong Workforce funds, 17% is performance based(2) Likely part of the funds will eventually be performance based but nothing along these lines has been announced
 - (2) Energy part of the fundas will eventually be performance based but nothing along these lines in(3) New State allocation funding model just announced will have a 25% completion component
 - ix) Final wording approved for three resolutions (now placed on AS Council meetings website as record)
 - x) Voted against removing the 3rd resolution—only Erik Reese was for the removal
 - xi) Approved the AS GP resolution as amended with Jazmir Hernandez voting nay and no abstentions
