#### IV) New Business

- a) Distinguished Faculty Chair (DFC)
  - i) Time for the call for the DFC to be set
  - ii) Process documents have been posted
    - (1) There was a question about how to decide to give the award
    - (2) Can secretly nominate somebody without their knowledge with the current process
    - (3) Some of the nominators would like the selection criteria to be reviewed
      - (a) Feedback was that the criteria were too vague and would like more specific criteria from those that nominated
      - (b) Comment: Flexible/broad criteria are good so that one can focus on the strengths of the nominee
    - (4) DFC committee members like the broader criteria to play to everybody's strengths
      - (a) Nominators and nominees should always be encouraged to re-apply if not successful the first year
    - (5) Council recommends no changes
    - (6) A recommendation for nominators is to submit a number of letters of support for a broader perspective
    - (7) Voted to approve the current criteria and process documents unanimously

#### V) Informational Item

- a) AP 7120-E: Recruitment and Hiring: Part-Time Faculty
  - i) Approved this AP twice last year for general changes and for the significant change that enables the call to go out to part-timers within the district first
    - (1) If take a part-timer that does not work at MC, for instance, then have option of evaluating that faculty member the first semester at the new location
    - (2) Question: PAL is college based so when does PAL and longevity come into play for guaranteed classes and how do they fit into the preference list?
      - (a) Reet Sumal—in the past it was after 2 semesters that they became official part of MC
      - (b) Would clarify with AFT
      - (c) Answers:
        - PAL is accumulated by course at each college; it does not transfer from one college to another within the district.
        - (ii) Longevity does transfer within the VCCCD but not until after completion of the first semester at the new college; as it is calculated at the start of the Fall semester it can take two semesters to transfer.
    - (3) What about full-timers that want to teach overload at other colleges in the district?
      - (a) The wording in the AP denotes a call to all faculty members, which includes both full and part-time faculty

      - (a) Study abroad advisory committee met for the first time on Thursday
        - (b) Want to come up with a rubric to plan and market the various study abroad ideas
        - (c) Will meet on a monthly basis...please come!
        - (d) This summer:
          - Beth Gillis-Smith—Scotland, England, Ireland with a Mar 1 recruiting deadline for ENGL M01B, taught online
          - (ii) Lydia Etman—Japan for an Asian art history class, taught online
          - (iii) Aiming for 15 to be enrolled in each of these classes to be offered for course credit; the trips will go forwards regardless of whether the courses run or not
    - (2) Sabbaticals
      - (a) Two years in a row that Oxnard College submitted only 1 proposal
      - (b) Each college has own process so that the rigor & philosophy of the selection vary widely between the colleges
      - (c) A discussion is planned with sabbatical chairs and AS presidents about how sabbaticals are being forwarded from the colleges; it will be advisory only:
        - (i) Moorpark's and Oxnard's process includes a step that does not forward proposals that are not up to par
        - (ii) Ventura's process forwards all proposals to the district
      - (d) Friday 11am A-138 VPAA Julius Sokenu and AS VP Nathan Bowen will hold a sabbatical orientation and a report back from those who had sabbaticals
        - (i) Will discuss expectations and timelines for those about to go on sabbatical leave
        - (ii) This meeting is now a requirement as part of taking a sabbatical
  - iv) President
    - (1) Management has agreed to fund the 5<sup>th</sup> faculty member—COM studies is the 5<sup>th</sup> position
      - (a) ENGL and BUS positions have yet to go out
