- Students need to be made aware of commitments that come with DE courses.

  - Discussed how DE fits within the mission of "students first" and supporting diversity
  - Suggested that students have a mandatory orientation by Counseling Dept. so that students become aware of DE requirements to help improve student success or retention rate.
  - 6. Joanna Miller:
    - Canvas Has been offered free through 2018. A one-year contract has been signed. Migration can start in fall 2016. Will we go to Canvas and leave D2L? DE Campus committees to make recommendations. VC Pilot, they really like it. Canvas is very easy to use, very intuitive.

- Suggested that students be required to assess themselves prior to signing up for DE. Will bring this topic up again at next meeting.

- Communication of Professional development is a current issue, not all faculty receiving the messages
