IV. Committee Reports

- **Curriculum Report (Mary LaBarge)**
Share Point has been set up for Curriculum Committee members to review COR's; it eliminates the need for duplicate copies with duplicate revisions.
- **EdCAP Report (Rolland Petrello)**
The proposal for a Career/Tech Ed Committee was accepted by EdCAP.
Program Improvement Progress Report was distributed to committee members- this document will be added to next year's Program Plans. ASEC will review this document at the December meeting. Margaret Tennant plans to distribute a communication flow path to chairs of committees so they are aware of who and when all involved parties should be included in their decision-making process.
- **Facilities CAP Report (Phil Abramoff)**
Academic Center: Contractor expects to be completed by Jan 2010 and ready for use by Fall 2010.
EATM Project: Need to repave an old road to permit access of heavy construction equipment to the EATM compound.
Parking: Loss of parking lots due to construction and sites for new buildings was addressed.
Possible solutions proposed are multilevel parking structure, use of Park n Ride lot and shuttles for student parking.
A bridge may be needed to cross Campus Road from upper parking lot to Health Science Bldg.

Classified hiring procedure was clarified.

DCSL (student learning) – procedures for repeatability of courses were addressed- it will be allowed when a course is needed to meet recency requirements for transfer or to meet prerequisites for a course.

Ad hoc committee considering Academic Senate policy on amplified sound on campus.

Amplified sound may only be used on “alternative teaching days”. Currently, the only alternative teaching day is Multicultural Day. Procedures need to be developed for establishing alternative teaching days.

The ad hoc committee will prepare a formal document for consideration by ASEC.

- **Faculty Hiring Prioritization**

Lisa Putnam, Moorpark College Institutional Researcher, distributed a Glossary of terms used in Program Plan Data Reports and explained each term to the committee. She encouraged ASC representatives to also read the sections on program strengths and weaknesses and take those into consideration for the prioritization process.

The Committee asked Lisa to prepare a table of Data for Fall 2008, and to combine Biology as a total instead of breaking it out by discipline, and calculate % of Part Time instructors.

- **VCCCD Academic Affairs Procedures – 2nd reading**

Procedures #4020, 4022, 4050, 4070, 4101, 4230, 4232, 4235, 4240, 4300 were under consideration.

It was moved, seconded, and vote was unanimous to approve these procedures.

- **District equivalency criteria – review and discussion**

Ad hoc committee consisting of Riley Dwyer, Rex Edwards, and Rolland Petrello was formed to examine this issue and report to ASC at a future meeting.

- **Career Tech Ed Committee proposal**

It was moved, seconded, and voted to approve the proposal for this new committee with a caveat that the committee membership have a broad-based campus-wide representation.

Vote: 22 for, none against, 1 abstention.

- **ASC concerns about IT support of instruction**

Margaret Tennant noted that a Programmer would be required to solve these problems with Banner.
