#### V. New Business

- a. New Faculty Prioritization DATE: Thursday, Nov 12. 3:00 to 7:00pm Thursday, Nov 5 @ 12:30 afterall
  - We do not expect to hire anyone next year, yet 30+ requests have been submitted for prioritization. We need to do this process just in case we DO get to hire. Plus we need to maintain a culture of people who know how to do this process. And we need to maintain the consistency of the process for accreditation purposes.
  - Nursing Position: We are out of compliance because we lost one full-time position at the end of spring (due to their Accreditation board) based on student/faculty ratio. Jeff has permission (from VP Council) to pull this position out of the prioritization process. When there is funding of any kind, the first priority will be to backfill all mandated categorical, second will be this nursing position.
  - Rollover 2008 position prioritization level for History, Graphics, and Nutrition? These positions were sent through process last year and had finalists chosen. These are valid through 5/15. However, due to financial climate, there might be a request from our Pres to request that these positions be placed back into the prioritization process. The senate will need to make this decision with the deans. There might be reasons that other positions might have stronger need, based on this past year's program plan/reviews.
  - What about the Music, Theatre and Librarian positions? Weren't these the three that were frozen from last year's prioritization process? Music was the only one hired. The three (History, Graphics, Nutrition) actually had existing POOLS of people who were close to being hired, not just a position.
  - We will vote on this on  $\frac{11}{12}$  11/5
  - Use an alternative assignment in your classes on this day so that you can attend this session.
  - Clint: Motion: Authorize the hiring of the nursing position giving funding. Motion ruled out of order.
  - Clint: Motion: Table the prioritization process for one year. Motion dies for lack of a second.

### b. Fall Fling Feedback:

Phil reports. We are waiting on the administrators to summarize the feedback. It was a productive meeting. The underlying theme was to prepare ourselves for the coming financial storm. Iris projected that we will drop nearly 10million in the next couple years. Divisions were then broken out to discuss their 18 units of core courses, then another 12 units as important. This conversation is important. What is the core within our disciplines? Some schools are not including faculty in these decisions. It is important to realize that we are being included. MC is collaborative, and it is important to recognize the two new VPs who are continuing this collaboration. Our new management is looking to the faculty for input and direction.

UC/CSU are also cutting enrollment, so students will be coming to CCs. The fling was just the beginning of these conversations.

Note: MC2 committee discussed the definition of "core." With demographics changing in 2012, keep in mind the career/vocation aspects of the programs (this wasn't clearly stated at fling).

### **Section D: Elections**

Elections for the offices of President, Vice-President, Secretary and Treasurer shall be run by an Elections Committee. This committee shall be comprised of five members reporting to the Academic Senate Council. Its duties shall include receiving nominations, organizing and overseeing all publicity, running the election, declaring the results, and adjudicating any disputes that may arise. All decisions of the Committee shall be final.

Volunteers for the Elections Committee shall be called for and its membership confirmed during the first meeting of the Academic Senate in March during election years. Any voting member of the ASC may volunteer, unless running for election, and if necessary the ASC shall determine by vote the committee's final membership. Upon first meeting, the Committee shall appoint a chair and vice-chair. The ASC Faculty Statement of Ethics shall provide the guiding principles for the decisions and actions of the Elections Committee.

All nominations for the executive officers shall be submitted to the Elections Committee no later than the first meeting in April, when it will announce the list of candidates to the ASC.

The Committee shall collate and distribute the position statements of all candidates. Any further publicity, whether from the ASC, the candidates or any other parties, must go through the Committee for approval before being circulated.

The Committee shall ensure that elections are held before the first meeting in May. Voting shall be by secret ballot. A simple majority of those Academic Senate members voting shall be sufficient for election. If no candidate receives a majority on the first ballot, a run-off election shall be held between the two candidates receiving the most votes on the first ballot. Any disputes before or during the election shall be resolved by the Elections Committee.

The Elections Committee shall announce the results of the election at the first meeting in May, upon acceptance of which by the ASC, the Committee shall disband.

Representatives from the college departments shall be elected as specified in the By-Laws.

## **Brown Act Coverage**

The Brown Act applies to the meetings of all legislative bodies (GC 54952) which includes:

- 1. The Board of Trustees
- 2. Any subcommittee of task force created by the Board with a majority of Board members
- 3. Any subcommittee or task force created by the Board which has a definite, ongoing charge (either decision-making or advisory) OR has a regular meeting schedule set by the Board, regardless of Board membership.

THIS MEANS THAT THE BROWN ACT APPLIES TO THE ACADEMIC SENATE AND ALL COLLEGE COMMITTEES RECOGNIZED BY THE BOARD AS ADVISORY OR DECISION MAKING IN ITS BOARD POLICIES.
