Nominations have been received and nominees have been contacted by email to confirm that they would like to run.

b. Waitlists (placeholder)

Ed Knudson addressed remaining concerns from Senate.

- It could be possible to adjust the waitlist somewhat proportional to the seat capacity "5 or 10% of seat capacity" was recommended. This is a Banner issue and therefore we need the other two colleges in agreement. Ed will take this forward. (Can we review typical attrition rates to make this decision? ... drops during registration as well as drops prior to census.)
- It is not possible to customize the waitlist based on faculty-preference programmatically it is not possible; the Registrar might be able to override the programming.
- On the first day of class, it is possible to only allow registration into the class to occur from the waitlist.
- Short-term classes were having difficulty moving students from the waitlist when instructor dropped registered students for no-show. Ed will investigate this glitch.
