II. Approval of Minutes

- b. January 15, 2013 Approved as amended

III New Business

- a. Letters of recommendation for full-time faculty (1st reading / re-reading)
 - DCHR has brought this topic back for discussion. Faculty had expressed an interest to again begin requiring letters of recommendation for full-time faculty applicants. Music/Dance Senator recommends that the requirement of the 1-year currency be removed; proposes 2-year currency. English/ESL Senator recommends that it was a maximum of 3 letters, allowing for fewer letters to be submitted. English/ESL Senator also expressed concern that requiring the letters could force applicant to notify current employer of application when they hadn't truly wanted to do so.

b. District Educational Master Plan

The District Educational Master Plan is currently under development. Focus group types of meetings will be held so that people can provide feedback on the documents that guide the institution over a given period of time. Our district is in deep need of a functional master plan. VC, Dr. Robyn Calote is our master planner, working with campus-based facilitators to gather information that will be taken back to DCAP for the writing of the plan. Discussion groups are to be as broad as possible. Groups include groups such as each of the participatory governance committees. Lee Ballestero, Hugo Hernandes and Lori Bennett will be facilitators would like to see the district go, in regards to educational planning. Which comes first – District or College Master Plan? District master plans are to help drive the college's master plan, with the college informing the district. English/ESL Senator requested that we insure to address the independence/uniqueness of each of the college campuses, and to address our concerns regarding MOOCs.

c. BP 2510: Participation in Local Decision Making

Technical Visit (of the State Academic Senate) occurred at the last VCCCD Board Meeting to talk about participatory governance should work. The State Academic Senate President mentioned the issue of collegial consultation. Collegial consultation is in regard to the administration's requirement to consult the Senate (faculty) on the 10+1. This can be done by "mutually agree" or "rely primarily" -- this district is exclusively "mutually agree".

"Rely primarily" means that the administration acknowledges the primacy of faculty in certain areas – faculty have primacy particularly in curriculum. We acknowledge the expertise of the discipline faculty, counselors and librarians. In regards to curriculum, rely primarily would be with the specific Senate of the college presenting the curriculum.

"Mutually agree" invites the board to ask very specific questions and in-depth discussion about curriculum. If we are rely primarily, the board asks more general questions but does not go into detail. When we disagree (faculty vs. administration), we keep "status quo" if the Board "rejects" the faculty's recommendations.

In regards to BP2510, ASC President (and VC and OC ASC Presidents are also taking this forward to their campus senates) recommends that we propose a change to the BP to break out which of the 10+1 items that we "rely primarily" and which are "mutually agree." ASC President would like for the Senators to review the "rely primarily" structure in place within the LACCD (handout) as an example. ASC Vice President will draft the language for our proposal; the Senate will review at next meeting.

d. AP 7120E: Recruitment and Hiring – Part Time Faculty

It is proposed that the hiring committee for part time faculty to only include the Dean as an optional position.

Motion: MC moves that the Dean's presence be mandatory in the hiring of part time faculty. Discussion: None -- it is self evident that the dean be on the hiring committee.

The Dean is necessary:

- Necessary for someone to represent the district making sure that everyone is on a level playing field. There already is NOT a hiring facilitator on these committees.
- A Dean will approach the hiring process with a slightly different perspective (collaboration, campus involvement, etc.) in addition to content expertise.
- It makes a statement about the importance of part time faculty.
- Only Deans can check references of applicants. Deans provide consistency across time.

In favor: Unanimous; Opposed: 0; Abstentions: 0. Motion carries unanimously.

Another Concern:

Section J: Reads as though the "exception" can be actually hired as a permanent position, where in the past, emergency hires had to go through a second hiring process if they were to become "permanent" part time faculty.

- e. AP 3900: Speech Time, Manner and Place
 Senators are asked to review for discussion at next meeting. This came to us through Vice Chancellor of Business Services, as they are the group that schedules outside groups to come onto campus. It is designed to be protective, but with protection comes restriction.
- f. BP/AP 5010: Concurrent Enrollment This has been updated to be in compliance with State regulations.
