D. Comparable Course List

Jerry and Letrisha Mai, Articulation Officer, reminded everyone that the comparable course C-ID deadline is this coming Friday, February 7, 2014. The VCCCD District Curriculum Alignment project is whereby the three campus Curriculum Committees are asking you to assist in the review of courses in your discipline, both at your campus and the other two district campuses, for the purpose of designating courses as "comparable" (similar in content) district-wide. Letrisha reminded the committee not only to look at the course numbering for alignment, but also to look at the content.

Lori Bennett sent out emails to Deans in each discipline, with a spreadsheet detailing a list of all active courses currently appearing in Moorpark, Oxnard, and Ventura Colleges' catalogs that require your review. The top portion of each discipline spreadsheet is for courses that match C-ID descriptors. In this case, faculty review is NOT necessary as these courses have already been deemed comparable through the C-ID approval process. Those courses listed in the bottom section of the attached discipline spreadsheet are those courses that DO require faculty review.
