Update from: September 1, 2020

- New members: Gasia Benlian, Student Representative and Christina Lee is replacing Olga Myshina for the Health Sciences
- Committee approved 127 courses with Blanket DE Addendum. More than half are still waiting for Department Chair and/or Deans approvals. Please follow-up with your department chair to ensure that your courses have submitted into "workflow" in CourseLeaf. In order to make the state December deadline, we need these to go to the Curriculum Committee by the Oct. 20 meeting.
- Discussion – a proposal to include in the COR an assignment addressing social justice and being culturally responsive. Curriculum representatives are to bring back to the division the proposal for further discussion and prepare a recommendation to move forward, or not.

- Continued its review of the college Enrollment Plan for this second reading and voted to forward it to the AS Council.
- Brainstormed data metrics for effective online pedagogy in our online world; thanks to Shannon Macias and Matt Calfin, DE Committee co-chairs, for joining the discussion. A

mid-semester report will be presented to the committee in November to help inform its planning role, especially in relation to enrollment management.

- Evaluated the success of the Areas of Interest breakout exercise that was included in the Guided Pathways Retreat in encouraging cross-program plan synergy. Thanks to Traci Allen, GP Faculty Liaison, for joining the meeting. The consensus was to hold a similar exercise within the Areas of Interest annually and at a time that would allow for new ideas to be included in program plans.
- During this discussion interest expressed by several members for reviewing how to write the program plans more effectively, calling for more cross-program synergy at this point in the process.
- Introduced discussion on how to implement the Joint Meeting with Fiscal Planning Committee next semester, as now called for in the *Participatory Governance Handbook*.

Fiscal Planning Committee (Co-chair: Erik Reese)

- Adopted goals for the 2020-2021 academic year that include more information on link between and allocations to local and district budgets, a focus on social justice, and implementation of a joint Fiscal/EdCAP meeting to review the previous planning and resource cycle and inform the new cycle
- Adopted classified prioritization assumptions, criteria, and guidelines and reviewed the process for the Classified Prioritization meeting on November 24, 12pm-2:30pm, which will be similar to that for this year's faculty prioritization. All updates to classified requests have a Nov 17 deadline so that final justification documents and ballot can be provided in a timely manner for enough time for review before the prioritization
- Discussed the updated initial guiding principles for budget reductions that is part of continuing discussions in the District Council on Administrative Services (DCAS). There was a suggestion to highlight racial and social justice elements by making these elements a stand-alone bullet towards the top of the list
- Reviewed the infrastructure model and the full-time equivalent student (FTES) report. Current estimates suggest Moorpark College is down 523 FTES from its target values

Strong Workforce Funding Changes: Adjustments for the use of Strong Workforce funds have been implemented statewide. These changes include the inability to spend SWP funds to support paid internships moving forward and the priority shift to supporting short-term training programs and non-credit/not-forcredit development in CTE. There is also increased communication that projects and data must reflect reality of the current labor market.
