Departmental Meetings

October 16, 2018 1:00pm RADT/Nuclear Medicine

Present: Robert Darwin, Rachel Beetz

RADT/Nuclear Medicine are keeping up with their assessment schedule due to the certification process. However, information for these courses is not up to date in TracDat. Fortunately, assessments have been ongoing at both the course and program level. Robert gave me a booklet with their assessment results for Fall 2018. The department had a meeting on October 26 to discuss program outcomes and future actions. Overall, RADT/Nuclear Medicine is keeping up with regular assessments and actions points but isn't using TracDat to organize their data for the last few years. eLumen Demo

Jennifer Kalfsbeek-Goetz reached out to me to ask about Canvas integration with our data system and I ended up connected with Janet and Laura at Oxnard College who were attending an eLumen demo.

There are two ways to connect canvas to eLumen that involve different faculty involvement in eLumen and

Canvas. Overall, It seems like eLumen allows more detail to be input into the system through canvas, meaning there would be less data organization outside of the system for the faculty member. However, even with the streamlined connection with canvas, it may involve more know-how of elumen/canvas use than using outside spreadsheets. Can do grading of assessment rubric in eLumen and it will keep track of the data. Would require best practices for all faculty to use together. (Whereas right now, seems like each area is figuring it out on their own.)

***There is still a glitch in eLumen regarding total connection between grading an assignment and having it connect to SLOs. Canvas rep needs to be involved in the process so softwares talk efficiently to each other. Can upload a spreadsheet as well!

Information can be seen at the student level - with each students' performance on the assessment listed. Students can be -allowed- to see their assessment scores - but this can also be hidden from them.

Fun Fact: Oxnard only has about 5 rubrics for the whole college!

After this meeting it became clear to me that I also need to have a meeting with Dean Mary Rees in order to be able to "close the loop" on some of the recommendations from a Spring 2018 GE Meeting such as: confirming the GE Review schedule and where information for GELOs can be housed.

December 7, 2018 1:15pm

Psychology Meeting

Present: Julie Campbell, Rachel Beetz Oleg Bespalov

All assessments are completed and need to be put into tracdat. We updated the necessary CLOs in tracdat so the system is now ready to receive the information.

Psychology had a meeting in Spring 2018 to update their CLOs. The Department overall is on schedule to be ready for their curriculum review next year.

Julie voiced several concerns on the tracdat system:

- 1. A lot of time is lost getting into the system (since it is not a part of SSO) and the practice of using the system is not clear. For instance, she didn't know that she couldn't update the CLOs, and needed me to do so.
- 2. Putting the information into the system is extra work for her as she already has the information clearly presented in word document format. To input the information into tracdat is extra hours only to have the reports from tracdat be less communicative than her word documents.

Action Items:

- 1. Need to communicate to SLO Representatives the process of updating tracdat system more clearly
- 2. Need to connect Julie to person who updates catalog. Completed Dec 2018
- 3. Look into SSO for tracdat?

Flex Day - "Consequential SLOs"

December 4, 2018 2:30pm

Flex Day Activity - "Consequential SLOs" + "Data Entry to Tracdat"

Danielle Viera gave a presentation on "Consequential SLOs" as a part of Spring 2019 Flex Day Activities.

Comments: Seems that it is not completely clear that SLOs are meant to empower departments to make decisions about their curriculum. That they can and should gather the information they need and also present and report it in a way that is most useful to them. Part of the issue is that TracDat is difficult to use and there is a culture around gathering "pseduo-science" and percentages of improvement that make faculty uncomfortable and perhaps do not really help departments. (They feel pressure to report majority percentages of improvement.) How can we present and encourage more qualitative action statements on the data and encourage departments that this process is for them. It seems that making them put the information into TracDat - makes them think the information needs to look a certain way.

Rachel made a worksheet for inputting information into TracDat. I have a lot of questions as to why we are using TracDat the way we are: If the Course Learning Outcome that is measured in TracDat is decided upon the departments and should be a level of abstraction above the specific Course Objectives - then why are we inputting the Course Objectives into TracDat? This makes faculty think they need to have measurements and results for each specific Outcome instead of the class as a whole. Shouldn't we be inputting the departmental approved, abstracted Course Objectives and only requiring faculty to input measurements and results for that single element? Or am I misunderstanding the process - CO vs CLO is confusing!

January 8, 2019 - 11:00AM

RADT/Nuclear Medicine

Present: Robert Darwin, Rachel Beetz

Reconnected with Bob because I still didn't see his information into TracDat. Because of the accreditation process for RADT/Nuclear Medicine, the department has decided to stay very much on top of assessing program outcomes. They do this every year and update the results on their MC website. Bob wanted to know from the committee **if the college requires their department to assess each course**. He could do this, but it is *not what the department has decided is important for their assessment process*. How he would be able to do it right would not be in a way that would benefit the department and wouldn't feedback into the programming as genuinely as the program assessment process does for them.

My provisional answer: the college requires each department to decide upon an assessment process that works for them and do it. But how that process looks is decided within each department. Since his department is on top of the Program Level Outcome assessments and these results are informing their program planning, that they are covering the requirements for the college.

More importantly: we discovered that he had updated the Program Planning part of TracDat with his assessment results and not the Outcomes portion.

Program planning also uses TracDat?! - The program planning login method seems to work more efficiently through Sharepoint Documents where TracDat is embedded into sharepoint. **Can and should SLO do this method too?**

Or is there a way to have TracDat talk to itself from program planning areas to Outcomes areas? Is this information the same? Action items in the Outcomes area really should be seen in the Program Planning page for genuine closing of the loops. Is there an official/technical reason that there is a separate page of data for the outcomes area in TracDat? Could best practice information be included in a sharepoint document for SLOs with TracDat embedded below? How does the new Curricunet affect the program planning process?
