I. Scholarships

Moorpark College Foundation raises funds for:

Named Scholarships

Named scholarships are generous gifts established in the name of a donor. They are directed to support students majoring in particular programs or areas of study.

Endowed Scholarships

Endowed scholarships are perpetual gifts to the college made in honor of a special person, event, or organization. Only the interest from the endowment is used to fund yearly scholarships, providing permanent support to students.

II. Basic Needs

College students, and their families, face unprecedented challenges as they pursue post-secondary education. The state of homelessness and food insecurity is at shocking proportions on college campuses throughout California and the country. Moorpark College students feel the same pain. According to surveys, 46% of students were food insecure in the last 30 days; 54.8% were waiting to receive emergency aid. Moorpark College is opening an essential need center and hiring a specialist in the Fall 2020 semester.

III. Building the student pipeline

Moorpark College's Rising Scholars Academy, in collaboration with California Lutheran University provides local middle school students, who may not be considering college, with a pathway to a bachelor's degree lined with substantial support and scholarships.

MCF's board is a working group of business professionals, alumni, adjunct faculty and representatives from the college's senior leadership team. Moorpark College Foundation's success is rooted in the commitment, guidance, support and financial resources provided by every member of the Board. Board members' responsibilities include:

- Make a leadership gift at the President's Circle level.
- Actively participate in fund development, through a variety of ways, including raising \$5,000 annually through direct philanthropic gifts, facilitating bequests, establishing scholarships, securing corporate underwriting and sponsorships and foundation grants.
- Attend at least 80% of all board meetings. Review meeting minutes, agendas and all other documents sent in advance to fully participate in board discussions and making important decisions.
- Actively participate as a member or chair of one board standing committee.
- Become familiar with the bylaws and Foundation policies.
- Represent the Foundation in important community relations activities and select college events. Invite community leaders and others to Foundation and Moorpark College events.
- Maintain the highest discretion with matters discussed in confidence.
- Continuously work to make the Foundation prosper, grow and function effectively.



Board Development Committee:
