- A. Action Item: ASMC Standing Rules (25 minutes).** ASMC Board of Directors will review proposed language to change its Standing Rules, specifically Article I, Composition; Section. C, Qualifications; Item 8, which currently limits a Board member's ability to serve at the head of club leadership. The Board may take action to change these limitations.

- B. Action Item: Possible ASMC Retreat (15 minutes).** ASMC Board will discuss whether to hold a fall planning and leadership retreat for its members. The Board may take action to approve the coordination of an all-day or overnight retreat.
- C. Discussion Item: Moorpark College New Student Welcome (10 minutes).** ASMC Advisor Kristen Robinson will update the ASMC Board on Moorpark College's upcoming New Student Welcome on Monday, August 9, 2021, from 9:00am – 1:00pm, including opportunities for ASMC to get involved in welcoming newly matriculating students on campus.
