Administration Building Reconstruction – preliminary documents were submitted to the state for this project today, as it is 50% state funded.	
Front Campus Marquee and Campus Wayfinding – both of these projects are in progress. Active construction on the marquee is underway, while wayfinding is in its submittal phase.	
Proposed Student Housing – the college has been given a grant for 320-bed student rental housing to be created from fallow commercial space. Construction will need to be completed in 2022 and 2023.

Jace was not able to attend today's meeting, but in his place, student representative Gabrielle Onnega presented his bullet point proposals for improved campus sustainability. A detailed draft of an actual plan for sustainability goals is highly encouraged for the next meeting; in addition, campus and district statistics as highlighted in today's bullet points were inaccurate and need correction.	
Regarding a Chumash mural on campus, Karin Johansson had volunteered to investigate multiple location options that can accommodate artwork on a removable canvas base. Her findings will also hopefully be presented at the next meeting.	
the north exterior side of the Gym, facing the generator. With this plan they suggested the replacement of the existing cypress trees nearby. Unfortunately, the tree roots are encroaching too closely to the building foundation and waterproofing, and are also interfering with utilities and roof drains. Suggested replacement plants are shrubs and bushes such as camellias, in addition to turf which would be more drought-efficient than the current grass yet more inviting than wood mulch for potential outdoor classes. Funding is requested for tree and stump removal, but money	The committee unanimously voted in favor of recommending the proposed planting plan and tree removal at the north exterior side of the Gym, as presented.

Suggested activities include a clothing swap, a jazz band, and the possible installation of a new plant near the Student Activities side of the Campus Center Building, as approximately \$2,000 has been set aside for that purpose. As the west side of Campus Center is already landscaped, Steve and Brian will need a detailed plan of what species of plant is desired, and what irrigation is required for its maintenance. Brian encouraged students to use research and caution regarding plant choices; not all native California plants actually thrive in the campus climate conditions. Lynda Dobson will also need to be contacted for assistance with organizing the use of any campus facility spaces with outside vendors.	Brian Sherman will forward links to educational websites regarding the care and upkeep of California plant life, for future committee references.
