IV. New Business

- A. Academic Senate Budget Update
 - 1. Ruth Nothing has changed since fall except we have received some checks that were deposited. Your paycheck deducted donations received will hit in March. It should be about \$3,200.

B. Scholarship Workgroup

- 1. Ruth I am looking for a few volunteers to review the scholarship applications and vote for who should get the scholarships. Of course, if you nominated somebody you cannot be on the committee.
 - a) Question How many applications are there usually?
 - b) Ruth Usually about 18 but I do not know this year yet.
 - c) Sydney volunteers to be on the scholarship committee. Jolie and Danielle also volunteered.

C. Brown Act Teleconference Suspensions During a State Emergency

- 1. Tiffany It is time to discuss the ability to meet safely. We need to discuss if the current emergency situation affects our ability to meet safely in person.
 - a) Comment As long we are masked, we should keep the option open to zoom.
 - b) Comment -I have two kids in k-12 institution and one of my kids teachers just went home with COVID. I'd prefer to stay at remote at possible.
 - c) Comment There are significant increases in covid since the masking mandate went away.
 - d) Comment I would like to speak in favor of and safer to allow for a remote option.
 - e) Comment I have a child who cannot get vaccinated yet. There are kids who still can't get vaccines yet. I would like to keep the remote option for safety.
 - f) Comment If there is one case in a room then we are all going to be on some sort of high alert. It is safer to be remote. So we can continue to maximize our work.
- 2. Chuck I motion that we continue the hyflex option to maximize safety for faculty, staff, and students at Moorpark College
- 3. Ruth seconds the motion
- 4. Comment Most people are out doing things in the world and I think it is okay for us to come back in person.
- 5. Comment Spring break is coming and case numbers may increase due to that.
- 6. Comment If we are talking about safety, ventilation is an issue.
 - a) Comment Our students are currently meeting on campus and we are told all of our buildings are at or above current safety guidelines.
- 7. Roll call vote Majority said yes with three no's from Roger, Nathan, and Jamee
- 8. Motion passes We have another 30 days to continue Hyflex until our next vote.

D. Guided Pathways Scale of Adoption Assessment (SOAA)

- 1. Kellie Porto-Garcia and I are bringing this to the Academic Senate Council for your consideration this semester. This process began here more than five years ago at Academic Senate Council at Moorpark College. This tool is designed to help us assess how far along we are toward adopting essential guided pathways practices.
 - a) Creating the Path
 - b) Getting the students to enter the Path
 - c) Keeping the students on the path
 - d) Ensuring their learning
- 2. Nenagh summarized what we are doing this year and what we have to do next year by walking through the Scale of Adoption Self-Assessment

- 3. Kellie A lot of the development this year has been software. One of which is the program mapper. We are updating the Program Mapper. Updating all that right now and it is a big project. The goal is to have it done by registration next month.
- 4. Scheduler is going to take what we currently have and making it more user friendly. They can put in what times they have commitments and put in the classes they would like to take and the program will generate several schedule options.
 - a) Question Is the idea that this would replace a counselor?
 - (1) Kellie It does change our role. A student can pull from degree works but there are some issues. Students can put in the classes suggested by the counselor to help make a schedule of those recommended courses.
- 5. Chuck This is just adopting. I would like to make a motion that the Academic Senate adopts the annual progress report on implementation of the guided pathways framework.
 - a) Dani Seconds the motion.
 - b) Roll call vote
 - c) The motion passes unanimously
- 6. Question Will faculty and department chairs get feedback about the popularity of individual classes and specific times from this software to help us with scheduling?
 - Nenagh We are working on that and this software does have some new abilities.
 - b) Kellie I will look into that and get back to you how to do that to make schedule adjustments as needed.
- 7. Question I think this scheduler will be really helpful because it takes so much time to figure out the schedule and will save time. Does it offer multiple schedule options?
 - a) Kellie Yes it does give multiple schedule options and allows you to play around with it based on your preferences.
- 8. Erik Thank you for all the work on putting this together.

E. Proposed Baccalaureate Programs

- 1. Assembly bill 927 has the pilot designation removed now for bachelor degrees offered at community colleges. There is a non-competition agreement with CSU's and UC's. This is offered through the chancellor's office with more accreditation pieces. Moorpark College is proposing two bachelor degree programs: Bio-Manufacturing and Applied Cyber Security and Network Operations. These come as recommendations from the curriculum committee to support these new programs. These also require upper division courses in other subjects only for those bachelor degree programs. Thanks to Mary Rees to make this happen. The advisory board gave unanimous support for the bio-manufacturing bachelor's degree.
- 2. Question Will we be offering other upper division courses?
 - a) Erik Yes but just for those students in the bachelor programs.
- 3. Sydney Motion to approve the Baccalaureate Programs of Bio-Manufacturing and Applied Cyber Security and Network Operations
 - a) Chuck Seconds the motion
 - b) Roll call vote
 - c) Motion passes unanimously

F. Credit for Prior Learning at Moorpark College

- 1. Erik Credit by exam has been on the books and basically legislation has increased the options for receiving credit for experience such as military or professional experience. This document links credit for prior learning options to specific classes. If faculty did not enter the options, the legislation was written so that the course automatically provides the opportunity for credit for prior learning. This document comes recommended by the curriculum committee.
 - a) Erik shared the excel spreadsheet for senate's approval.
- 2. Question In regards to some of these courses that say yes. Will there be an option for faculty to update it?
 - a) Yes, It is a living document. If you want to make changes, send them directly to Scarlet, Letrisha, and/or Ana.
- 3. Question Are you asking for a vote today? I would like to take this to the next meeting so that we can take it back to our department in regards to pre-requisites.
 - a) Erik If we take no action it will automatically come back to the next meeting. This is the first read.
- 4. Question Where can find this information?
 - a) Erik There will be some information in the course catalog about where to find this information.
 - b) Comment It would be great if it is clear where students can find this information.
- 5. Comment I am grateful to Letrisha and Scarlet who have been working on fine tuning this. I do believe moving forward that the list should be online and counselors will have access to it, too.
- 6. Erik After our last discussion, based on how the legislation was interpreted, the catalog will only list the classes that give credit for prior learning instead of the entire list of all the classes. There is some room to wait and make sure all departments are comfortable with this document.

G. Great Teachers Seminar Process

- 1. FACCC's <u>Great Teachers Seminar</u> is going to be in person August 7 August 11. We have the process documents that we wanted you to review and hopefully approve. We updated the dates and a couple of the names. It is the same we approved previously. The fees are covered by Academic Senate and the only thing that costs extra is if you would like a single room. The second document is the application itself. When completed, they are emailed to the Academic Senate Vice President. The facility has gorgeous views and the seminar itself offers a lot of professional development.

- 3. Chuck Make a motion to approve the process documents for the Great Teachers Seminar.
