### Background

ACCJC Accreditation Standard 1: Mission, Academic Quality and Institutional Effectiveness, and Integrity, A. Mission (ACCJC, 2021) states that *"the mission describes the institution's broad educational purposes, its intended student population, the types of degrees and other credentials it offers, and its commitment to student learning and student achievement."* VCCCD Board Policy 1200 Mission Statements (VCCCD, 2021) is aligned with accreditation standards and regularly updated to reflect timely changes to the District and colleges' mission statements.

Moorpark College recently updated the Moorpark College Mission Statement. The statement represents the work of students, staff, faculty, and administration. In campus discussions last summer, groups raised the question, "Does Moorpark College's Mission Statement accurately represent the College's commitment to social justice?" A re-examination of our Mission was on the list of actions defined by the Social Justice Workgroups. A sub-committee of Social Justice Workgroup # 4 re-defined the Mission. This draft was then presented and edited with input from Executive Administration, Academic Senate, Classified Senate, Associated Students, and Standing Committees, as well as with broader input from the campus at Moorpark Updates. The draft Mission Statement was presented and approved during the College's April 23, 2021 Annual Retreat.
