Hi Gloria and Andrea,

If I recall correctly, both of you had worked on the update to the Standard III.A section on Human Resources for our current accreditation report. I will be working on compiling all of the pieces into a single document and want to make sure I am working from the most up-to-date version.

In reviewing the draft that is in the Teams folder, it looks like 6 of the III.A standards (7, 8, 9, 10, 11, and 14) still have the language from 2016. I am not sure who I should talk with regarding those college-specific HR updates.

Should I be working with a particular Moorpark College HR person to complete those sections? Or, maybe college-specific information is located in an alternate location that is different from that main Teams folder?
